Treasurer Accounts

Brethren.... These last few weeks and months has been trying for our professional families, our personal families, and certainly our masonic family. I hope and pray that each of you, your families, and friends are well. Covid-19 will soon become a part of Texas Masonic History.

It seems like a lifetime since I saw many of you at the 5th Annual Alamo Remembrance Program in February. It was an honor and pleasure to have Most Worshipful Paul Underwood attend, and participate, in this historic occasion. It has been my distinct pleasure to have been involved in this innovative program over the last five years. As I step down from the coordination and management role, I proudly hand the reins to Brother Senior Warden Jon Wych. I am confident in his ability to continue and improve the program going forward! Please join me in congratulations to Brother Wych and please stand behind him in his endeavors.

Regarding the finances of the lodge, I have some thoughts I would like to share with you.

The Treasurer of the lodge is a **position of trust and profound responsibility**. Think about what the duties of the treasurer are; "To receive all moneys from the Secretary, make due entries thereof, and pay them out by order of the Worshipful Master AND consent of the Lodge". The Treasurer does not pick or chose, but performs his duty with those two criteria in mind at all times; by order or the Worshipful Master AND consent of the lodge. When the Worshipful Master formulates a budget and it is presented to, and approved by, the lodge; this becomes easy... the approved budget becomes the order and the consent. If an expenditure is presented that is not contained on the budget, a vote is required to justify the expenditure. When the lodge does not have an approved budget for the current masonic year, you will hear the Treasurer, usually after the Treasurer's Report during stated meeting, ask for permission to 'pay the bills'. This fulfills the duty... request for an order, and consent; on a month to month basis.

Another part of his duties is the receipt of all moneys from the Secretary, making due entries thereof. What does this mean? The Grand Lodge of Texas requires double entry bookkeeping. This meaning that no one individual manages the receipt and disbursement of funds. Instead, all moneys DUE the lodge are received by the Secretary. The secretary records the moneys received, categorizes them (dues, donations, fund raiser, Grand Lodge disbursements, etc. He then pays them to the Treasurer who verifies the amounts, denominations (if cash), checks, square receipts, etc. in order to confirm what is being payed to him so he can make the deposit and record the information for the accounting report (Form 71) and assure that the lodges books are correct. These functions continue, regardless of if a pandemic is occurring, weather, or other conditions. These processes cannot be put off, without negatively impacting the lodge, including its financial health and reputation.

We are fortunate; Webb really only has two monthly operational bills; Water and Electricity, both of which are paid online, but if you have been to a lodge meeting in the last 3 years, the electric bill, during the winter, can be brutal. Our water bill, fortunately, is pretty stable. Of course, we have

the Grand Lodge per capita, MWSA and MSB donations, the 64th district breakfast donation and other such items that come up each year.

Scholarships are managed separately. We have been spoiled over the last couple of years. When the Webb Community Center closed, the organization that managed the center made a sizable (nearly \$10,000) donation to our scholarship account. This has been a blessing, but without replenishment, those funds will dwindle and soon disappear. Unfortunately, we have had to rely on some of those funds to literally keep the lights on.

This brings me to my second point. **FUNDRAISING.** Brethren, to be blunt... without the concerted effort of every brother in creating, managing, working and promoting fundraising, the financial future of Webb Lodge is challenged at best. This is not just for Scholarships. Scholarships are special and may be a future installment... I will focus on Ops.

Our dues do not cover the operating costs of running this lodge. Not with the other expenses outside of the standard bills. We need to do better managing our electric utilization especially during the winter. We must also formulate a means to bring in additional funds (registration fees on the Motor Rally is one that does not require an initial investment), the TMRC booth with some small and donated items to sell has been another. We sold a custom bench recently that had to potential to be quite lucrative, but fell short of what was anticipated. We need something else. My suggestion has been to host a Car Show with registration fees going to our operations account. Maybe a monthly Breakfast/Dominoes tourney? Dime a day? Think outside the box. But remember, a raffle, by state law, cannot be used for a fundraiser that is NOT for charitable use. Charitable Raffles are managed by the Lottery Commission of the State of Texas with very explicit rules and regulations on how they can be operated. Let's work together, and make this happen. "Fundraising does not have to be complicated, but you need eight to ten months to start planning. There is no fundraising without MARKETING"-Worshipful Sam Gibbins

Brethren, it has been my pleasure to be entrusted as lodge treasurer for the last two years. I am certain that whoever the lodge votes to be treasurer in the future years will perform his duty with integrity and attention to detail... but let us work hard to give him something to work with.... Also, be thinking, is this something you would like to do? I can assure whoever it is, I will be there to assist in assuring a smooth transition.
